### SHOW FEES

Stall fee: \$150 per stall. Stabling reservation form attached.

Haul In Fee: \$60 per show for all non-stabled horses regardless of HPW membership status.

Hunter/Jumper Class Fee: \$30 per class.

Dressage Test Fee: \$35 per test.

Friday Schooling Round: \$20 per round.

CDFA Fee: \$8 per horse.

HPW Facility Fee: \$25 per horse. \*Applies to all horses regardless of HPW membership status.

Office Fee: \$25 per horse.

Late Entry Fee: \$50 per horse if submitted after September 8<sup>th</sup>.



## FRIDAY SCHOOLING ROUNDS

Non-judged schooling rounds for hunter, jumper, and dressage rings on Friday, September 17, starting at 1:00 PM. **Schooling rounds can be purchased at the show office or online. Rounds will be permitted on a first come, first-serve basis for each height section. Sign-up sheets will be available at the in-gate starting at 1:00 PM for each ring.** Horse number must be worn at all times. Number of rounds will be recorded at the in-gate. Fence height for jumpers and hunters will follow the schedule below. Arenas will close at 5:30 PM.

# SCHOOLING SHOW GUIDELINES

## Guidelines:

- All riders must complete an entry form and sign a release form.
- ASTM rated hard hats must be worn by all riders when mounted at The Horse Park at Woodside.
- Stallions may not be shown by juniors. USEF rules apply\*
- No martingales permitted in hack or flat classes.
- All dogs must be leashed at all times when at The Horse Park at Woodside.**
- No open fires, smoking or BBQ's at The Horse Park at Woodside.
- Speed limit is 10 MPH. Parking only permitted in designated areas.

## Friday Schooling Rounds:

- Schooling rounds and dressage schooling will be available Friday, September 17<sup>th</sup> from 1:00 PM to 5:30 PM.
- Sign-up sheets will be available at the in-gate for each arena at 1:00 PM on Friday.
- Purchase a schooling round with each entry online or through the show office. Entry number must be worn while riding. Number of rounds will be recorded at the in-gate of each ring on Friday.
- Rounds are \$20 each and non-refundable.

## Hunter Divisions:

- Classes will be judged on the rider's position, pace and control of the horse. Proper show turn out will be rewarded.
- Champion and reserve awarded for each hunter division as follows: Walk/Trot, Poles, 2', 2'3", 2'6", 2'9".
- Equitation classes are open to junior and amateur riders only and will not be included in hunter division placings.

## Jumper Divisions:

- Lower height classes:** First class in each height (.60m - .90m) division will be Optimum Time. Second class in each height division will be Table II, Section 2c – immediate jump off round. In the event of a tie, optimum time will be used as the tie-breaker.
- Higher height classes:** First class in each height (.90m – 1.10m) divisions will be Table 2c (immediate jump off). Second class in each height division will be Table II, Section 1 - speed class. In the event of a tie, time in the speed class will be used as the tie-breaker.

## Dressage Divisions:

- Ride times** will be posted on Friday September 17<sup>th</sup>.

## SCHOOLING SHOW RULES AND REGULATIONS

The following rules and regulations will be enforced for the duration of the show and apply to all competitors, riders and visitors on the property.

- 1. Entries** will be accepted until the closing date of September 8<sup>th</sup>, 2021. Additional administrative late fees will be assessed for late entries.
- 2. Adds / Scratches: No same day adds will be allowed for any class.** Same day scratches will be allowed. Add/Scratch forms will be available at the show office.
- 3. Show Scratch / Refunds:** A “Show Scratch” is applied to any horse entered in the show that does not show in any classes. In order to be eligible for a refund, show scratches must be submitted in writing (email only) by the deadlines described herein. Show Scratches submitted before the official closing date for the show entered will receive a full refund of the stall fee, the registration fee, and any other fees paid. Show Scratches submitted after the closing date will only be refunded registration fees and will not receive a refund of the stall fee. **Show Scratches submitted after the show begins on Friday September 17<sup>th</sup> will not receive a refund.**
- 4. Payment** is accepted in the form of check or credit card. **Competitors are required to close out at the show office before leaving the show.** A 3% credit card processing fee will be added to all credit card transactions. Credit card authorization form is found in the Prize List and at the show office. Checks should be made out to “The Horse Park at Woodside.” Any checks returned by the bank will be charged a \$35 penalty in addition to the returned check charges made by the bank.
- 5. Open Balances:** competitors who do not close out their balance by the end of the show forfeit the right to adjust any show charges. Final balances will be charged to the payment method on file. Prior outstanding balances must be paid before picking up show numbers.
- 6. Dogs** must be on a leash **at all times** and are not permitted in the arenas or on courses.
- 7. Management** reserves the right to refuse, accept conditionally, cancel entries, awards or prizes and/or adjust the time schedule, combine, scratch or move classes as necessary without claims or damage. A two-minute gate call will be requested and enforced. All judge’s decisions are final.
- 8. Stall Use** is by reservation only and availability is subject to change. To reserve a stall, fill out and return the attached stall reservation form or select a stall with your online entry. Pricing and amenities are listed on the stall reservation form. By renting a stall at The Horse Park, you agree to abide by the **stall use policies.**
- 9. Feed & Shavings** can be purchased before arriving and during the show either through your online entry, or with the attached Feed & Shavings form in the Prize List. Each stall reservation includes 2 bags of shavings.
- 10. Move-In** for horse stalls starts at **10AM** on check-in date. Anyone arriving earlier than 10AM on the specified check-in date will be asked to wait.
- 11. All Competitors will be charged a \$25 HPW facility fee, regardless of HPW membership or boarding status.**
- 12. Non-Competing horses** that are stabled or hauled in for the show will be required to pay for stall or other applicable entry fees.
- 13. Schooling:** No juniors or amateurs are allowed to school over fences without having a person in charge on the ground.
- 14. Arenas:** Competitors are restricted to show arenas and warm up arenas. Competitors who are not also members of The Horse Park are not permitted to use “member only” arenas. Members who are not competing are restricted to “members only” arenas and may not use show designated arenas.
- 15. Lunging** is permitted in designated lunging areas only: South Lunging Pad or North Lunging pad. Do not lunge in warm up or show arenas.



- 16. Photo and Video Consent:** By competing or attending competitions or events at The Horse Park at Woodside, I grant permission to the unrestricted rights to use photographs and/or video footage of myself, my family, my guests, and/or my animal(s) for the purpose of promotion of The Horse Park at Woodside in various mediums.
- 17. No draw lines/reins allowed in the show ring.**
- 18. No trainers** allowed on foot in the show ring during competition.
- 19. Management** reserves the right to not allow same day adds.
- 20. Management** reserves the right to dismiss riders displaying extreme aggression or force, or riders who seem unsafe.

## **HPW STALL USE POLICY**

The Horse Park at Woodside is implementing the following as a Stall Use Policy effective April 1<sup>st</sup>, 2019. Going forward stalls will be inventoried before and after each rental to ensure that stalls are returned in the same condition as they were received. Any damages to rental stalls will be the financial responsibility of the owner, exhibitor and/or trainer. Please review the following guidelines and contact the main office with any questions or concerns:

- 1. Do not damage stalls: No staples, nails, bolts, screws, liquid nail, rubber cement, duct tape, paint or other products to be used on or in the stalls.**
  - 2. Decorations must be attached using temporary set-ups (wire or plastic ties) and removed prior to check out.**
  - 3. Name cards must be removed prior to check-out and leave no residue on stall surfaces.**
  - 4. Do not remove any part of the stalls.**
  - 5. Manure only in dumpsters.**
  - 6. No vehicles in the aisles between stall rows.**
